Tax System to promote investment in equipment for productivity improvement

The Industrial Competitiveness Enhancement Act came into effect on January 20th, 2014. The act includes the “Tax System to promote investment in equipment for productivity improvement”, which is a taxation system for the immediate amortization or utilization of tax credits up to 5% for high-quality capital. Its purpose is economic revitalization and industrial competitiveness enhancement in Japan. Robots are subject to the taxation system. Please contact the nearest sales office regarding the requirements and procedures for issuing certificates.
